- There was a credible mountain lion siting around mile marker 11.5 of the American River Parkway. We have had reports over the course of the last couple of months of a mountain lion in the area between Campus Commons and Riverbend. There have not been any negative interaction reports with this lion; therefore, no warnings have been posted. While Rangers were patrolling Deer Creek Hills, they observed 3 American Bald Eagles eating salmon along the Consumnes River.
- Rangers assisted in the suspicious death of a male located in the slough along the SAFCA north loop by Railroad Avenue. Sacramento Police Department took the lead in this investigation and we provided support as needed. A second death was reported in the same area. There were no signs of foul play with this victim and the investigation continues.
- A two person Ranger unit pulled over a car inside Riverbend Park. The driver was non-compliant and resisted the Rangers as they tried to detain him. This occurred next to the suspect's vehicle, and he was able to get back into the driver's seat. Rangers were right next to the car and one was partially inside the driver's compartment when he sped off. One Ranger was dragged a short distance and received non-life threatening injuries. The second Ranger remained standing but rolled down the side of the vehicle and was not injured. The Sheriff's department provided a great deal of assistance and took the suspect into custody several hours later after the incident.
