4. Conceptual Approval Of The River Bend Area Plan Map Amendment For Camp Fire Day Camp Area (Leatherman/)

The American River Parkway Plan 2008 (ARPP) provides the scope and nature of operations for the area designated as the American River Parkway in the County of Sacramento. The Camp Fire Day Camp is located within the River Bend Area of the American River Parkway. On July 26, 2011 the Board of Supervisors approved the Camp Fire Day Camp Master Plan and adopted a Negative Declaration (Control No. 2009-70118) with associated mitigation monitoring and reporting requirements. In order to be consistent with the policies of the American River Parkway Plan, prior to construction of the new facilities contemplated in the approved Master Plan, an Area Map Amendment for the River Bend Area Plan is required.

Recommendation:

Conceptually approve the proposed River Bend Area Plan Map Amendment including icons for a parking lot, restrooms, and interpretive area, and direct staff to bring it to the Board of Supervisors for final approval.
