Overview

Eagle Scout applicant Scott McCuen presented a concept to the Department which includes the installation of bike repair stations at three locations along the American River Parkway. The Commission directed the Department of Regional Parks to finalize the locations for the repair stations and request and Environmental Review of the project.

Recommendation

The Department recommends that the commission:

- 1) Find the Notice of Exemption adequate and appropriate; and
- 2) Approve the final locations and authorize the installation of the bike repair stations.

Measures/Evaluation

The proposed action fits into the "Sustainable and Livable" County Strategic Objective and supports Regional Parks stated Performance Measure: to provide safe, accessible, and clean recreational facilities for Park users.

Fiscal Impact

Mr. McCuen would fund and coordinate the installation having no initial cost to the Department. The Department will absorb the ongoing costs for the tools, vandalism and other ongoing maintenance costs.

BACKGROUND

Mr. McCuen will provide the background and concepts to the Commission in his presentation.

DISCUSSION

American River Parkway Advisory Committee (ARPAC)

The ARPAC heard the presentation from Mr. McCuen on August 16, 2013 and made the recommendation to approve the project and forward it to the Recreation and Park Commission for consideration. The Recreation and Park Commission heard the initial presentation in August and approved the concept. Comments were heard about the potential implications of the sponsorship and advertising component of the bicycle repair station and compliance with the American River Parkway Plan. Staff committed to ensure the advertising and sponsorship program was designed to be compliant with the American River Parkway Plan and consistent with existing sponsorship programs currently permitted on the parkway.

The project scope was reviewed by the Division of Environmental Review and Assessment (DERA). DERA staff issued a Notice of Exemption, Control Number 2013-70104 for the project.

MEASURES/EVALUATION

The proposed action fits into the "Sustainable and Livable" County Strategic Objective and supports Regional Parks stated Performance Measure: to provide safe, accessible, and clean recreational facilities for Park users.

FINANCIAL ANALYSIS

Mr. McCuen would fundraise and coordinate the purchase and installation of the bike repair stations having no initial cost to the Department. The Department will absorb the ongoing e costs for the tools, vandalism and other ongoing maintenance costs.

NOTICE OF EXEMPTION

Project Title:

AMERICAN RIVER PARKWAY BICYCLE REPAIR STATIONS – BSA EAGLE SCOUT PROJECT

Project Location:

The project consists of three locations along the American River Parkway bike trail as follows: (1) approximately 50 feet downstream of the Guy West Bridge; (2) abandoned concrete slab of an old restroom site at Sunrise PCA Bridge; and (3) William Pond Main Restroom area.

Description of Project:

The project consists of an Eagle Scout Project to install bicycle repair stations at three locations in the American River Parkway. The bicycle repair stations will consist of a metal bike stand and some basic tools for quick repairs along the bike trail. The Guy West Bridge location will require installation of approximately 29 square feet of concrete and the William Pond location will require installation of approximately 38 square feet of concrete.
