- Rangers were invited to participate in an “active shooter” training day during the month of August. Several Rangers were able to attend this valuable training. This training is important because it allows Rangers to train with other law enforcement officers from the area, since active shooter incidents usually draw a large multiagency response. It is also important training since there are several schools that border Regional Park facilities.
- Rangers assisted Sacramento Police Department with a social media driven event at Sand Cove Park. Rangers participated in a multi-agency enforcement effort by sending a Ranger team on our patrol boat to the Sacramento River by Sand Cove Park. Even with the increased enforcement effort in that area, we did not experience any “spill over” to Tiscornia Beach or Sutter’s Landing area of the American River. We did have Rangers assigned to those areas in case people relocated there to avoid the law enforcement presence at Sand Cove.
- Rangers responded to an illegal dumping of a hazardous material on Zinfandel in the Mather Preserve area. 14 5 gallon buckets containing isopropyl alcohol were dumped on a dirt road. A report was taken and special crews had to respond to clean the area. No active leads in this case.
- The Park Resource Team with the assistance of Department of Human Assistance was able to get three people off of the American River Parkway into temporary housing. We continue to work with our county partners dealing with homeless issues within Regional Parks. In addition to the three peopled housed, the Park Resource Team referred 6 additional people to DHA.

We have changed the format for tracking our illegal camping data. We will now be tracking the total number of illegal camps cleared, total number of illegal camping citations, and amount of debris removed from Regional Parks.
