## August 2015

- The condition of the boat launch at hogback island in the delta made it unusable
- 3 Illegal camps and a rope swing on Parkway mile 6N
- Many off leash dogs on all of the horse trail at Sailor Bar. Couple of bikes on trail, too
- The county has placed "No Parking" signs throughout the whole neighborhood for Sarah Park. This is reverse discrimination!
- There were 5 or more men sitting around a camp site in wooded ravine in River Bend Park
- They have set up a "camp" in the base of the first large Walnut tree(to the right of the trail) – off Mira Del Rio
- Two white males in mid 20's camping in the creek bed – Dry Creek Parkway
- There is a pile of gear, sleeping bag, blankets, shoes, etc. along the walking trail between the Mayhew Drainage Canal and Gristmill entrance
- Three tents setup in Ancil Hoffman gravel bar.
- Camp site set up made out of tarps has a pile junk next to it. is west of organic farm and north of Dedo Crt. in Riverbend Park.
- Homeless camp in area between west side of mitigation area & bike path – Riverbend
- A couple is camping along the north side of the American River across from the 15 mile marker.
