On January 2, 2019, Rangers responded to an airplane crash on the American River by Tiscornia Beach. Sacramento Fire had a full contingent on scene, dealing with the victims as well as securing the airplane. Due to the government shutdown, NTSB did not respond, so Rangers took a report documenting the facts and sent the report to NTSB for any other follow up they deemed necessary. There was one fatality.

A patrol ranger came upon a homeless couple who had a six year old child while patrolling Discovery Park. With the assistance of the Park Resource Team and Department of Human Assistance we were able to secure temporary housing to get the child off of the American River Parkway.

Patrol Rangers recovered stolen merchandise taken from a burglary at Sportsman's Warehouse located on Sunrise Avenue. The property was returned to the business, and no arrests were made. Rangers were assisting Rancho Cordova Police with some follow up along the American River Parkway.

Rangers and the sheriff deputies received a call of a suicidal subject by the PCA Bridge. Rangers and sheriff deputies located the subject at the Sacramento Bar river access. They took him safely into custody for a mental health evaluation and recovered the handgun.

One of our Park Resource Team sergeants was watching the news and saw a story regarding a homicide within the City of Sacramento in an area known for homeless people congregating. The sergeant reached out to the case detective to inquire if they needed any assistance in identifying witnesses or suspects. The detective shared some information regarding the suspect, and rangers were able to have the potential suspect identified very quickly. Our rangers continue to offer to assist outside agencies with investigations related to homeless individuals who may be living along or are associated with the American River Parkway.
